frequent regeneration cycles and reduced fuel efficiency. The CK-4 formulation ensures that Bobcat engines remain compliant with Euro V and Euro VI emission standards while extending the life of aftertreatment components.

The chain case also acts as a heat sink for the drive motors, requiring a fluid with high thermal conductivity.

For technical personnel, the oil change procedure is the most critical maintenance task. Following this structured workflow ensures system integrity and prevents contamination.
